RETEL FROM PITTSBURGH, NOVEMBER TWENTY EIGHTH, RE  
JULIO C. FERNANDEZ. MIAMI FILES REFLECT FOLLOWING.

ON NOVEMBER SEVENTH, SIXTY ONE, FOLLOWING MISCELLANEOUS  
COMPLAINT RECEIVED BY TAMPA AGENTS FROM [REDACTED]  
[REDACTED] SANTA FE RENCH, SEBRING, FLA.

JULIO CESAR FERNANDEZ, WIFE NENA, ADDRESS UNKNOWN,  
MIAMI, WAS ALLEGED TO BE ANTI AMERICAN, PRO CASTRO, AND TO HAVE  
WORKED AS NEWSPAPER WRITER FOR PRO CASTRO NEWSPAPER BEFORE  
COMING TO US. COMPLAINANT EXPRESSED OPINION THAT SUBJECT AND  
WIFE ARE COMMUNISTS BUT POSSESSED NO SPECIFIC INFORMATION UPON  
WHICH TO BASE ALLEGATION. COMPLAINANT SAID NENA FERNANDEZ,  
EMPLOYED AS SOCIAL WORKER IN QUOTE LIBERATION MOVEMENT UNQUOTE  
IN MIAMI, IS [REDACTED] AND FELT SHE MIGHT BE IN THIS  
MOVEMENT AS A QUOTE ANTI LIBERATOR OF CUBAN PEOPLE UNQUOTE.

MIAMI FILES CONTAINED NO OTHER INFORMATION REFLECTING UPON LOYALTY.

DURING NINETEEN SIXTY TWO FERNANDEZ AND WIFE WERE  
SUBJECTS OF CASE ENTITLED QUOTE JULIO CESAR FERNANDEZ, EMMA

~~LARRAZ FERNANDEZ~~, FAG CONSPIRACY UNQUOTE. CASE BASED UPON ALLEGATION RECEIVED AUGUST TENTH, SIXTY TWO, FROM CUBAN REFUGEE ASSISTANCE PROGRAM THAT FERNANDEZ, TWENTY FOUR SIXTY TWO SW SIXTEENTH TERRACE, MIAMI, APPLIED FOR AND RECEIVED FINANCIAL AID UNDER THIS PROGRAM AND HAD FAILED TO DECLARE HE HAD OBTAINED EMPLOYMENT WITH CATHOLIC WELFARE BUREAU, MIAMI, WHICH WOULD AFFECT HIS ELIGIBILITY TO RECEIVE AID. INVESTIGATION DISCLOSED THAT FERNANDEZ DID RECEIVE WELFARE AID WHILE HIS WIFE WAS EMPLOYED, THEREBY AFFECTING HIS ELIGIBILITY. FURTHER INVESTIGATION ESTABLISHED, HOWEVER, THAT CUBAN REFUGEE ASSISTANCE PROGRAM MADE ERROR IN TABULATING ASSISTANCE RECEIVED BY FERNANDEZ AND THAT HE DID NOT RECEIVE ANY ASSISTANCE TO WHICH NOT LEGALLY ENTITLED. AUSA DECLINED PROSECUTION.

RECORDS, DADE COUNTY MOTOR VEHICLE REGISTRATION, INDICATE THAT FLORIDA LICENSE ONE D THREE NINE NINE SEVEN ISSUED TO E. FERNANDEZ, TWO THREE ONE ONE SOUTHWEST FIFTEENTH STREET, MIAMI, FOR SIXTYTWO CORVAIR.

~~DELFA LARRAZ~~, TWO THREE ONE ONE SOUTHWEST FIFTEENTH STREET, MIAMI, ADVISED THAT E. FERNANDEZ IS EMMA FERNANDEZ, WIFE OF

JULIO FERNANDEZ SEMICOLON, THAT EMMA FERNANDEZ IS SISTER OF ~~ANTONIC LARRAZ~~, HUSBAND OF ~~DELFA LARRAZ~~. E. FERNANDEZ OWNED A METALLIC GREEN CORVAIR AUTOMOBILE. SHE NEVER ACTUALLY LIVED AT TWO THREE ONE ONE SOUTHWEST FIFTEENTH STREET, BUT USED THAT ADDRESS. SHE LEFT MIAMI OCTOBER TWENTYEIGHT LAST IN THE CORVAIR TO JOIN HER HUSBAND JULIO FERNANDEZ IN MARTINSBURG, PENNSYLVANIA. SHE WAS ACCOMPANIED BY HER TWO CHILDREN, AGES SIXTEEN AND NINE.

MRS. LARRAZ STATED JULIO FERNANDEZ LEFT MIAMI EITHER IN DECEMBER SIXTYTWO OR JANUARY SIXTYTHREE VIA AIRLINE OR TRAIN FOR WASHINGTON, D. C. HE WAS ACCOMPANIED BY HIS NINETEEN YEAR OLD SON, JULIO. JULIO AND EMMA FERNANDEZ NOW LIVE AT FOUR ZERO ZERO EAST ALLEGHENY, MARTINSBURG, PENNSYLVANIA. JULIO FERNANDEZ IS A HIGH SCHOOL TEACHER. MRS. LARRAZ STATED NONE OF THE FERNANDEZ FAMILY HAVE VISITED MIAMI SINCE THEY LEFT, TO HER KNOWLEDGE.

IN VIEW OF PREVIOUSLY MENTIONED ALLEGATION REGARDING JULIO FERNANDEZ, MRS. LARRAZ INTERVIEWED AT LENGTH CONCERNING HER KNOWLEDGE OF POLITICAL SYMPATHIES OF FERNANDEZ. SHE STATED SHE HAS KNOWN FERNANDEZ FOR MANY YEARS, ALTHOUGH THE TWO FAMILIES HAVE NOT BEEN UNUSUALLY CLOSE. SHE STATED, HOWEVER, FERNANDEZ HAS ALWAYS EXPRESSED OPPOSITION TO COMMUNISM AND, IN FACT, LEFT CUBA BECAUSE HE COULD NOT TOLERATE RAISING HIS CHILDREN UNDER THE COMMUNIST SYSTEM. TO BEST OF HER KNOWLEDGE, FERNANDEZ HAS NEVER HAD COMMUNIST ASSOCIATES OR SYMPATHIES. SHE DESCRIBED HIM AS VERY PEACEFUL PERSON, PRIVATELY CONCERNED WITH THE WELFARE OF HIS FAMILY.

~~REDACTED~~ RESERVATIONS CLERK, SEABOARD RAILROAD, MIAMI, MADE AVAILABLE DIAGRAM OF CAR THREE E FOR THE TWELVE FORTY P. M. TRAIN SEPTEMBER TWENTYFIVE SIXTYTHREE. THE DIAGRAM INDICATES THAT THE RESERVATION FOR SEAT FORTYEIGHT IN CAR THREE E WAS MADE IN THE NAME OF HERNANDEZ, THAT THE TICKET

INDICATES THAT THE SEAT NEXT TO HERNANDEZ WAS UNOCCUPIED.  
OTHER SEATS ADJACENT TO SEAT FORTYEIGHT WERE NOT OCCUPIED  
AT THE TIME THE TRAIN LEFT MIAMI.
