PHILADELPHIA, ADVISED SA BRUCE G. ERICKSON, NOVEMBER THIRTY SIXTYTHREE THAT HIGH SCHOOL AND NURSING SCHOOL CLASSMATE, CHRISTINA SUAREZ, NOW MRS. CHRISTINA S. DE TORANO, WHO RESIDES SEVEN EIGHT FOUR ONE SOUTHWEST TWENTYNINTH STREET, MIAMI, FLA., HAS A BROTHER, MIGUEL

SUAREZ, WHO WAS BELIEVED TO BE EDUCATED AT A MILITARY ACADEMY IN CUBA AND HAS TAKEN PART IN THE CASTRO DEFENSE AT THE BAY OF PIGS IN NINETEEN SIXTYONE. CHRISTINA DE TORANO TOLD [REDACTED]

THAT MIGUEL SUAREZ HAD TOLD HIS SISTER TWO YEARS AGO THAT PRESIDENT JOHN F. KENNEDY WOULD BE KILLED BY CASTROITES. [COMPLAINANT ONLY RECENTLY LEARNED THIS.] PROTECT IDENTITY OF COMPLAINANT IF POSSIBLE.

PHILADELPHIA INDICES CONTAIN NO IDENTIFIABLE REFERENCES WITH SUAREZ.

MIAMI WILL INTERVIEW CHRISTINA DE TORANO RE EXACT STATEMENTS OF BROTHER AND WHEREABOUTS OF MIGUEL SUAREZ NOVEMBER TWENTYTWO SIXTYTHREE.
