FOR INFORMATION DALLAS, TAMPA ADVISED LETTER RECEIVED NOVEMBER TWENTYTHREE LAST FROM ██████████ PETERSBURG, FLA., TO EFFECT YOUNG MAN IN HENDERSONVILLE, N. C., STATED IN SEPTEMBER SIXTYTHREE THAT A MILLION DOLLARS SHOULD BE RAISED TO KILL KENNEDY. ██████████

ADVISED THE STATEMENT MADE BY YOUTH EMPLOYED AS HANDYMAN, EDGEWATER APARTMENTS, HENDERSONVILLE, N. C., OWNED BY J. E. JACOBSON.

JOSEPH E. JACOBSON ADVISED OTIS JOHN DEAN EMPLOYED AS LABORER AT EDGEWATER MANOR APTS, HENDERSONVILLE, NC, JUNE TWENTYFOUR TO SEPTEMBER FOURTEEN LAST UNDER SSN TWO THREE NINE DASH SEVEN TWO DASH ZERO SEVEN ZERO SEVEN. JACOBSON STATED RECALLS DEAN MAKING STATEMENT WITH REFERENCE TO QUOTE SHOOTING OR KILLING KENNEDY. UNQUOTE.

JACOBSON STATED CONSIDERED STATEMENT TO HAVE BEEN IRRESPONSIBLE THOUGHTS OF TEENAGE KID.

DEAN, WM, BORN NOVEMBER SIXTEEN FORTYFOUR, HENDERSON COUNTY, NC, ADVISED RECALLS MAKING STATEMENT TO UNRECALLED INDIVIDUAL PAST SUMMER WHILE EMPLOYED EDGEWATER MANOR APTS TO EFFECT QUOTE MONEY SHOULD BE COLLECTED TO PAY SOMEONE TO SHOOT KENNEDY. UNQUOTE. DEAN STATED HE HAD REFERENCE TO THE ATTORNEY GENERAL, ROBERT KENNEDY. DEAN STATED THIS WAS JUST IDLE CONVERSATION AND WAS THE RESULT OF PUBLICITY RE INTEGRATION.

DEAN STATED HAD NO INTENTION OF CARRYING OUT ANY ACT WITH REFERENCE TO ABOVE STATEMENT. NO MONEY COLLECTED BY HIM OR ANYONE ELSE. DEAN ADVISED NOT MEMBER OF ANY ORGANIZATION ADVOCATING OVERTHROW OF U.S. OR OTHER HATE-TYPE GROUPS. CREDIT AND IDENTIFICATION RE DEAN HENDERSON COUNTY AND HENDERSONVILLE, N. C., NEGATIVE.
