BRAY, ROUTE ONE, BOX ONE FOUR FOUR, TELEPHONE
NUMBER EY EIGHT DASH TWO SEVEN THREE SIX, CORRIGAN, TEXAS,
ADVISED SA ROBERT E. WIATT ON NOVEMBER THIRTY INSTANT, THAT
HE AND HIS WIFE, CLYDIE, RESIDED DOWNSTAIRS APARTMENT,
ADDRESS UNKNOWN, WEST NEELEY STREET, DALLAS, TEXAS, FROM
FEBRUARY TO MAY SIXTYTHREE. IN MARCH SIXTYTHREE UPSTAIRS
APARTMENT OCCUPIED BY LEE HARVEY OSWALD AND WIFE. OSWALDS
WERE MOVED INTO THIS APARTMENT BY WOMAN DRIVING WHITE STATION
WAGON, WHO TRANSPORTED THEM AND PERSONAL BELONGINGS.

BRAY STATED HE AND HIS WIFE BOTH WORKED FULL TIME AND
HAD LITTLE CONTACT WITH OSWALD. MRS. OSWALD SPOKE NO ENGLISH

AND NO CONTACT HAD WITH HER. OSWALD APPEARED TO BE UNFRIENDLY AND BRAYS MADE NO ATTEMPT TO BECOME BETTER ACQUAINTED.

WHILE OSWALDS RESIDED UPSTAIRS THEY WERE VISITED OCCASIONALLY BY ONE OR TWO YOUNG COUPLES. NO FURTHER INFO KNOWN CONCERNING THESE. OSWALD AND WIFE OFTEN QUARRELED LOUDLY AND ON OCCASION THESE QUAPRELS OCCURRED IN PRESENCE OF UNKNOWN MALE VISITOR, WHO UTILIZED BACK STAIRS TO VISIT OSWALDS. THIS MAN DESCRIBED ONLY AS WHITE MALE, CHUNKY BUILD. OSWALDS MOVED OUT IN EARLY MAY, SIXTYTHREE, AND NO FURTHER INFO KNOWN OF THEM BY BRAY. INSERT FOLLOW.
