STATED THAT, WHILE IN CALIF. RAISING FUNDS FOR ANTI CASTRO
ACTIVITIES, PHYSICIAN OR DENTIST CONTACTED WHO TOLD BROWN HE
WAS IN PROCESS OF ATTEMPTING TO RECRUIT AN ASSASSIN FOR PRESIDENT
KENNEDY. [REDACTED] GOT IMPRESSION CONVERSATION REFERRED TO BY
BROWN TOOK PLACE ABOUT OCT., NINETEEN SIXTYTWO, AND BELIEVES
PHYSICIAN OR DENTIST RESIDED LOS ANGELES. PHYSICIAN OR DENTIST

ALSO EXTREMELY ANTI CASTRO. STATEMENT PASSED OFF BY [REDACTED] AT THE TIME AS ANOTHER CRACK POT ANYTHING CAN HAPPEN IN CALIF. END QUOTE.

CAPT. ROBERT KENNETH BROWN, THE SCHOOL BRIGADE, FT. BENNING, GA., ADVISED SA CHARLES PAUL ROSE INSTANT DATE HE HAS BEEN ACTIVE IN CUBAN MATTERS FOR SEVERAL YEARS AND DURING SPRING OF SIXTYTHREE IN CONNECTION WITH ANTI CASTRO ACTIVITY, WAS IN CONTACT WITH NATIONAL STATES RIGHTS PARTY /NSRP/ GROUP, LOS ANGELES. DR. STANLEY L. DRENNAN, M. C., THREE SEVEN FIVE WONDERSVIEW DR., NORTH HOLLYWOOD CALIF., ACTIVE IN NSRP AND BELIEVED MEMBER, HAD BROWN AS GUEST IN HIS HOME. DRENNAN STATED IN GENERAL CONVERSATION IN ESSENCE THAT HE, DRENNAN, COULD NOT DO IT BUT WHAT THE ORGANIZATION NEEDED IS A GROUP OF YOUNG MEN TO GET RID OF KENNEDY, THE CABINET AND ALL MEMBERS OF AMERICANS FOR DEMOCRATIC ACTION AND MAYBE TEN THOUSAND OTHER PEOPLE. BROWN ADVISED HE IMMEDIATELY "BACKED OFF" OF DRENNAN AND PASSED THE REMARK AS BEING "CRACKPOT" THOUGH FURTHER CONVERSATION ON THIS SUBJECT WITH DRENNAN AND BROWN OBTAINED IMPRESSION DRENNAN PROPOSITIONING HIM ON THIS MATTER. BROWN HAS BEEN TO CUBA SEVERAL TIMES AND PRIOR TO

PHILLIPS, FOUR TWO THREE BRICKEL POINT, APT. TWO C, MIAMI.

BROWN AGAIN IN CONTACT WITH DRENNAN DURING SUMMER OF SIXTY
THREE AND DRENNAN RELATED HE HAD BEEN INTERVIEWED BY SECRET
SERVICE RE HIS REMARKS. BROWN STATES HE THINKS WILSON MAY HAVE
FURNISHED INFORMATION TO SECRET SERVICE AS HE DID NOT PLACE ANY
CREDENCE IN INFORMATION AND DID NOT FURNISH IT TO ANY GOVERNMENT
AGENCY.
