

Confidential information received by the Intelligence Unit of the Miami Police Dept Miami, Fla on Dec 2, 1963. Interrogation conducted by Det. E. Kay; transcribed on Dec 3, 1963 by P/woman Mary Gilbr...

Informant:

I left Miami, Fla on Nov 26th at 5:30 P.M. on a Greyhound Bus bound for Columbia, S. C. I arrived in Columbia, S. C. the following day at 11:00 o'clock; I put my luggage in a locker at the Greyhound Bus Station, and taken a cab to West Columbia, S. C. to Delton Sims. And he was not there, and his secretary said that he had gone to market, and she called the market, and he was there, and he told me to bring me over to the market, which she did. It was a short distance from his office.

When I arrived at the market, got out of her, and went in, and he was about half way in the store, and he told me not to say anything and he was getting some meat ground, and he was going to take his girlfriend's home whose name was Mrs. Mathews, and she lives on a street which had no numbers on it, but he delivered the meat to her, and we went back to his office, and he called A. D. Boland, Grand Dragon of the Association of the S. C. Klan at Swansea, S. C. and told him to meet him on Highway 322 about 10 miles south of S. C.

We left shortly thereafter and drove on Highway 322 south of Columbia, S. C. and we came upon the Grand Dragon's car parked on the left side of the road going west. We drove about 50-60 feet before we turned out in the woods. We met the Grand Dragon and he asked me "How well do you know A. D. Boland?" I told him "I have connections with the C. L. ... in New Orleans at the ... several times when I ... about this hard core ..."

So, I told him that was all I knew about Milteer, Mims repeating, stated that the money was given to Brown, and he in no way wanted it used or any part of it, that the Association in S. C. had contributed, to assassinate the President of the United States. And he was a little worried due to the fact that he did not know, that Brown was a good friend to Milteer, and he had never heard this. And Milteer told him while in Columbia, that he knew a good Patriot in the Conway section, of S. C., but at that time, he couldn't think of his name. He wrote him a letter with a pamphlet in it accusing the Jews of the assassination of Mr. Kennedy that he give the man's name as Dr. Cox, and he said that he knowed Dr. Cox was a very hard core man, and that he didn't deal with the Klu Klux Klan because he said that there was nothing to the Klu Klux Klan. That they didn't do nothing, but run around and collect money. This man is a very dangerous man, and we don't deal with him. We know him, but we don't deal with him. I don't get this stuff together the way that I would like to he said, "It looks to me like there is a hard core being set-up by a group without letting the public know it" and I said, "Well, I don't know, all I know is what you told me about the hotel room and the rest and of course he told me that you can use your own judgment know as to what to do with it. We know you have with Milteer", he said, "Well, we are going to put them out the side of the Electoral, and we are going to put them out that he sent me, and I am going to go with it, until I find out more about him", and he said "he said that he knows Shelton, and we don't get along with Shelton" and he said, "I just don't know where we stand, further more he knows Stoner, and this is a man we don't do much business with, and we don't want him and the States Right Party in the state of S. C.", so he says, "I don't know just exactly what to think of this situation, but I want you to find out just as much as you can from Milteer just how he is going up just what he is doing, and let me know", I said, "Well, I will do my best". He said, "So far as attacking the N.A.A.C.P. is concerned, that is something ought to have been dead a long time ago. I know of certain attempts that had been made to kill him but they fell through, but so far as going out and killing public officials and what not to be associated with that at all, and he would not be associated with it."
