ASSASSINATION OF PRESIDENT JOHN E. KENNEDY

A PHOENIX MAN ADVISED THIS OFFICE INSTANT DATE THAT DURING NINETEEN FIFTYNINE AND EARLY NINETEEN SIXTY [HE MANAGED] A ROOMING HOUSE AT FIVE TWO ONE TWO GASTON AVENUE, DALLAS, TEXAS, OWNED BY MRS. BERTHA CHEEK. [INFORMANT] STATES THAT CHEEK-S SISTER, A MRS. JOHNSON, ALSO HELPED IN RUNNING THIS ESTABLISHMENT, AND THAT FROM PICTURES OF MRS. JOHNSON HE HAS SEEN ON TELEVISION FEELS THAT SHE IS MRS. A. C. JOHNSON, RENTER OF ROOM TO SUSPECT OSWALD.

[INFORMANT] STATES THAT [JUST PRIOR TO HIS LEAVING THIS JOB AS MANAGER,] TWO CUBAN MALES RENTED A ROOM IN THIS BOARDING HOUSE FOR A PERIOD OF ABOUT SIX WEEKS. REPORTEDLY BOTH MRS. JOHNSON AND MRS. CHEEK WERE QUOTE QUITE FRIENDLY UNQUOTE WITH THESE TWO MEN. NO FURTHER DESCRIPTION OF THESE MEN GIVEN, NOR INFORMATION RELATIVE TO THEIR ACTIONS OR REASONS FOR BEING IN DALLAS.

[INFORMANT SAYS] MRS. JOHNSON AND MRS. CHEEK HAVE RECEIVED MENTAL CARE IN THE PAST, AND ALSO, THAT MRS. CHEEK OWNED THE TWIN OAKS APARTMENTS IN DALLAS, AS WELL AS ABOVE ROOMING HOUSE.
