JOHN BIRCH SOCIETY AND ASKED IF LEADERS OF JOHN BIRCH SOCIETY
INTERVIEWED. SIMONS REQUESTED SHE BE ALLOWED TO TAPE RECORD
INTERVIEW AT WHICH POINT INTERVIEW TERMINATED.

SIMONS, DURING INTERVIEW, WAS VERY BELLIGERENT AND
REQUESTED SHE BE ADVISED WHO FURNISHED FBI WITH HER NAME.
