DETECTIVE CAPTAIN HERMAN STAHL, IN CHARGE

AN ANONYMOUS TELEPHONE CALL FROM A CALLER WHO SAID HE WAS
SANE, AND WELL EDUCATED, AND THAT HIS CALL WAS NOT A PRACTICAL
JOKE. CALLER SAID HE HAS A BROTHER WHO IS A MEMBER OF IRA
DASH IRELAND AND FOR THIS AND OTHER OBVIOUS REASONS DESIRED
TO REMAIN ANONYMOUS. CALLER SAID HE RECEIVED WORD FROM A
RELATIVE IN IRELAND INFORMING THAT THE IRA WILL ATTEMPT TO
GET A COMPANY OF IRA MEMBERS INTO THE UNITED STATES VIA
