ASSASSINATION OF PRESIDENT JOHN F. KENNEDY, NOV. TWENTYTWO LAST, DALLAS, TEXAS.

RE POSSIBLE PRESENCE OF LEE HARVEY OSWALD IN EL PASO, TEXAS, SEPT TWENTYNINE AND OCT. ONE LAST.

ON NOV. TWENTYSIX LAST ROSS JOHNS, TRANSIENT, ADVISED FBI IN MIDLAND, TEXAS THAT HE WAS IN HOLLYWOOD BAR, EL PASO, SEPT. TWENTYNINE OR OCT. ONE LAST AND MET A MAN THERE BY NAME OF FNU OSWALD. OSWALD-S GIRL FRIEND, A MEXICAN GIRL FROM JUAREZ, WAS WITH HIM, AS WAS ANOTHER MAN. WHEN JOHNS SAW PHOTO OF LEE HARVEY OSWALD IN NEWSPAPER, HE FORMED OPINION THAT LEE HARVEY OSWALD WAS IDENTICAL WITH MAN HE MET IN HOLLYWOOD BAR.

THE MAN BY THE NAME OF OSWALD, WHO APPROACHED JOHNS AT THE HOLLYWOOD BAR, OFFERED TO SELL JOHNS SOME DOPE AND SAID HE COULD GET ANYTHING FOR JOHNS THAT JOHNS WANTED ACROSS THE RIVER, MEANING IN MEXICO, AND THAT IF JOHNS NEEDED ANYTHING OSWALD COULD BE CONTACTED AT THE HOLLYWOOD BAR.

JOHNS IS CURRENTLY ENROUTE EL PASO AND PLANS TO CONTACT EL PASO OFFICE.

CUSTOMS AGENCY SERVICE, EL PASO, ADVISED THIS DATE THAT IT HAS HAD SEVERAL NARCOTICS CASES INVOLVING PERSONS WHO PATRONIZED THE HOLLYWOOD BAR IN THE PAST, BUT HAD NO INFO RE ANYONE WHO MIGHT BE IDENTICAL WITH LEE HARVEY OSWALD.

DALLAS REQUESTED TO IMMEDIATELY ADVISE EL PASO IF THE WHEREABOUTS OF LEE HARVEY OSWALD ON SEPT. TWENTYNINE AND OCT. ONE LAST HAVE BEEN ASCERTAINED SO THAT EL PASO OFFICE WILL BE GUIDED IN ITS INVESTIGATION RE ABOVE INCIDENT.
