On 12/2/63, Dr. JULIO GARCERAN DE VALL Y SOUZA, aka Dr. JULIO GARCERAN, voluntarily came to the Miami Office and furnished to SA GEORGE E. DAVIS, JR. a 15 page report dated 11/30/63, typed in Spanish, addressed "to the Director of the Federal Bureau of Investigation through Mr. GEORGE DAVIS". This report was not solicited from him.

Dr. GARCERAN explained that he was delivering the document in this manner as he did not wish it to be forwarded to the Bureau unless it had some merit.

Dr. GARCERAN is President of the Pro-Gobierno Constitucional de Cuba (For a Constitutional Government of Cuba), with offices at 222 N.E. 17th Terr., Miami. This is an anti-FIDEL CASTRO organization of Cuban exiles which advocates overthrow of the Communist regime in Cuba and restoration of the Cuban Constitution of 1940. Dr. GARCERAN

is a former Cuban Supreme Court Justice. He has been very cooperative with this office and has always exhibited a pro-United States attitude. He has the reputation of being a man of good character.

A translation of Dr. GARCERAN's report reflects that it is an analysis of the assassination of President JOHN F. KENNEDY on 11/22/63, at Dallas, Tex. It is based upon alleged facts garnered by him through public source media. Dr. GARCERAN advised that he possessed no information obtained through independent sources.

In his analysis, Dr. GARCERAN draws the following conclusions:

- 1) LEE H. OSWALD did not act alone.
- 2) JACK RUBY was used in the plot to silence the assassin in order to protect the other participants.
- 3) CASTRO-Communism is responsible for President KENNEDY's assassination, because
 - a) OSWALD is a Communist sympathizer and was in touch with the Cuban Embassy in Mexico in September, 1963.
 - b) In the first week in September, 1963, while at a reception in the Brazilian Embassy in Cuba, FIDEL CASTRO uttered threats against the "governors in the United States"; and on May 2, 1963, the Cuban newspaper "Revolucion" published an article predicting President KENNEDY's death.
 - c) The technique used in the assassination of President KENNEDY is like that employed on 4/9/48, in Bogota, Colombia, by FIDEL

CASTRO and others in a Communist conspiracy which resulted in the assassination of JORGE ELIECER GAITAN, leader of the Liberal Party in Colombia.

d) President KENNEDY was assassinated because he was a staunch defender of democracy, and he had promised that Cuba would not be abandoned.

Also, CASTRO proclaimed his innocence immediately after the assassination, even though he was not accused.

CASTRO is a combination of Communist, gangster and paranoic.

He violates international law whenever it is convenient for him to do so.

His goal is to produce subversion throughout America.

CASTRO uses terror as a method of taking power and as a method of government.

So long as CASTRO-Communism remains in power, no American nation will enjoy peace and no American governor or president will be safe.
