The destructive trend, coupled with the unprecedented and shocking powers through "executive order" vested in President Kennedy, must be contested through every legislative media available to the citizenry.

What are U.S. executive orders? They are issued by the President for the purpose of giving administrative authority to a "law or treaty or provision of the Constitution." These orders may be executed without either the knowledge or consent of Congress. Executive orders have the force of law by simply being published in the Federal Register.

On February 20, 1962 a series of ten executive orders were published in the Federal Register, without the knowledge of the general citizenry. These orders, apparently, give the President dictatorial powers for a take over. The executive orders granting this power are numbered 10995 and 10997 through 11005. An eleventh executive order, 11051, published October 2, 1962, gives authorization for putting all other executive orders into effect. The ten executive orders provide for: Take over of communications media; all electrical power, petroleum and gas, fuels and minerals: food resources and farms, including all equipment for farming; all modes of transportation and control of highways, seaports, etc.

Mobilization of all civilians into a work force under government supervirton; all health, education and welfere functions; designates posimaster general to operate a national registration of all persons; provides for take ever of all airports and aircrafts; grants housing and finance administrator power to relocate communities, build new housing with public funds, designate areas to be abandoned as unsafe and establish new locations for populations; and finally provides for take over of railroads, inland waterways and public storage facilities.

There is a total lack of precise description of the conditions or situations under which President Kennedy could enforce the above 10 executive orders. He could proclaim a state of "national emergency," a term that is not clearly defined. Any situation that the President sees fit could permit him to take over. These laws could be implemented if our country were to be attacked either by "overt or convert" methods, or seemingly, if we were to enter a period of economic crisis or a "civil rights" crisis.

These powers, vested in the President, could be used at his whim, to give him the authority of a Caesar.

Write your Senator and Representative now. Ask for the rescinding of these powers. All executive power must come from the consent of the governed, through the Congress.

#### HAROLD M. MIKKELSEN

Harold M. Mikkelsen worked as an undercover agent for the Federal Bureau of Investigation in Detroit, Michigan, from November, 1948 until December, 1953 at which time he publicly exposed himself as an undercover agent at the Smith Act Trials. Mr. Mikkelsen was an extremely valuable witness to the House Com mittee on Un-American Activities Hearings held in Detroit on May 4, 1954. His was a most difficult and hazardous job in serving our Nation. He had to reluctantly engage in interse day to day communist activity to finally qualify to be chosen by communist leaders as top security officer in the conspiracy. This gave him access to the higher echelon of the conspiracy, and was, therefore, one of the most productive undercover agents ever to serve. He had a photographic mind and was able to accurately relate much detail. He named more than three score communists.

The following short testimony should remove doubts from the minds of those who cannot believe that the conspiracy involves the ministry:

Mr. Mikkelsen: Then I met with Rev. John Miks. The first night I went to Michigan Avenue, Rev. John Miles was there . . . and was the second man in Michigan Avenue with whom I shook hands in connection with joining the Michigan Avenue Club (cell of the communist party).

Later . . . Rev. John Miles and myself spoke at the Civil Rights Congress . walking down the hall together . . . he told me he was teaching his Sunday school class dialectical materialism (communism). I met with him in connection with the Communist Party on a number of occasions.

Karl Prussion, who publishes "Heads Up," is a former F.B.L undercover open ative, having served in this capacity for 12 years.
