PARK, ILLINOIS, ADVISED SA VERNON G. SMITH ON NOVEMBER TWENTYFIVE INSTANT FROM PAYROLL RECORDS OF THAT COMPANY THAT LEE OSWALD, SSN FOUR THREE THREE DASH FIVE FOUR DASH THREE NINE THREE SEVEN, BEGAN EMPLOYMENT WITH BRANCH OFFICE, THAT COMPANY, TWO ZERO ZERO DASH E, NORTH VACEK STREET, FORT WORTH, TEXAS, AS A SHEET METAL HELPER ON JULY SEVENTEEN, NINETEEN SIXTYTWO. THIS EMPLOYMENT WAS TERMINATED OCTOBER EIGHT, NINETEEN SIXTYTWO, BY REASON THAT OSWALD QUIT. BRANCH MANAGER, LESLIE WELDING, AT FORT WORTH, HIRAN CONWAY, REPORTED BY LESLIE TO HAVE BEEN CONTACTED BY FBI, FORT WORTH, AND OSWALD-S ORIGINAL EMPLOYMENT APPLICATION OBTAINED. LESLIE STATED ALL OF OSWALD-S CANCELLED PAYROLL CHECKS WITH THAT COMPANY FURNISHED SA JAMES H. PARKER, 5 DEC 17 1963 INTELLIGENCE DIVISION, TREASURY DEPARTMENT, NOVEMBER TWENTYTHREE LAST.
