

MICHAEL MARCHESE, 3926 Shoshone Street, advised he is employed by the Jacobs-Kerr and Company, truck manufacturers, 1950 31st Street, and resides with his parents at the above address.

MARCHESE stated that he has never used or been known by the name "PIGGY" MARCHESE and has never known anyone using this name at Denver or anywhere else. He advised that he has only been in Dallas, Texas, once in his life and that was on or about November 1, 1963, when he passed through Dallas while delivering a truck for the Jacobs-Kerr Company to Bryan, Texas. He stated that he never knew JACK RUBY or LEE HARVEY OSWALD, has never been in the Carousel Lounge in Dallas and does not know NANCY ELAINE PERRIN. He stated that some years ago he knew a RUDY MARCHESE but that this man was no relation of his and he never knew RUDY to use the name "PIGGY" MARCHESE.
