PORTLAND NEWS REPRESENTATIVES ADVISE THAT THERE IS ASSOCIATED

PRESS STORY TONIGHT FROM TEXAS TO EFFECT THAT ONE [REDACTED]

[REDACTED], ASTORIA, OREGON, CONTACTED

SECRET SERVICE AGENTS AT LBJ RANCH, JOHNSON CITY, TEXAS, TODAY WITH ALLEGED INFORMATION AS TO ASSASSINATION OF PRESIDENT KENNEDY.

FOR INFO BUREAU, DALLAS AND SAN ANTONIO, OFFICER DARYL ROSS, ASTORIA, OREGON POLICE DEPARTMENT, ADVISED TONIGHT THAT [REDACTED]

[REDACTED] IS WELL KNOWN TO THAT DEPARTMENT AS A MENTAL CASE. SHE HAS BEEN MAKING COMPLAINTS TO ASTORIA PD SINCE NINETEEN SIXTYONE CONCERNING MEN HARRASSING HER WITH SEX MACHINES AND PEOPLE COMING AT HER FROM THE WALLS, ETC. SHE IS CONSIDERED BY ASTORIA POLICE AS DEFINITE MENTAL SUBJECT. SHE IS RECALLED AS MIDDLE-AGE TO ELDERLY.

IN VIEW OF ABOVE, NO FURTHER ACTION BEING TAKEN BY PORTLAND.
