ASSASSINATION OF PRESIDENT JOHN FITZGERALD KENNEDY

Set out below is a true copy of a letter dated January 11, 1964, received by the Federal Bureau of Investigation (FBI) Headquarters:

"Vicenza, 11th January 1964

"Mister Edguar Hoover,

escusing my delay, I would wish to you and your G-men a very happy new year to the end that American justice can cut every shape of transgressesion, that there is for many years. I'd like to know how I could do to enter the F.B.I.
