I desire to return to the United States, that is if we could come to some agreement concerning the dropping of my legal proceedings against me. If no, then I would be free to ask the Russian authorities to allow me to leave. If I could obtain them my American passport I am of the opinion they would give me on spot basis they have at her time insisted that I take Russian citizenship. I am living here

with non-permanent type paper
for a foreigner.

I cannot leave Miami
without permission, therefore I
am writing rather than calling
in person.

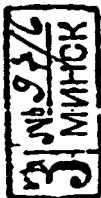
I hope that in meeting

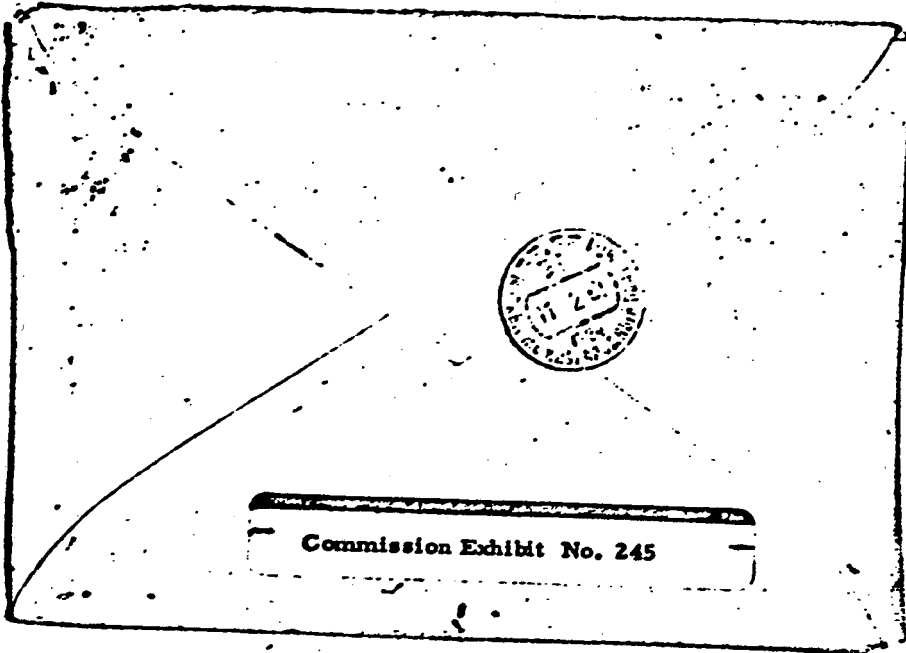
