Arthur G.4 Inhoff was contacted by Special Agents of the Federal Bureau of Investigation. Mr. Imhoff resides in a small house trailer located at the "Blossom Kine", a gold mine located two miles north of Searchlight, Nevada. Imhoff identified his occupation as "hard rock miner". He said he is a geologist and mining engineer." "hard rock miner". He is attempting to locate a new gold vein at the location of the "Blosson Mine". 11 Imhoff speaks Spanish, Cerman, and French fluently. He is a frequent visitor to Mexico where he has engaged in wining operations over the past several years. He said that his present partner in the "Blosson Mine", Mr. Edward Mageshoffer, had also been with him in Mexico several years ago. had also been with him in Mexico several years ago. Aleita Mr. Inhoff was unable to recall any specific . . conversations he may have had with anyone concerning the assassination of the late President Kennedy. He said that in the past he has heard a great deal about so-called "scors" and "mystics" who claim to have predicted the assassination of President Kennedy before it happened. He recalled reading about a woman, whose name he could not recall, who claims to have written a letter to someone in Washington, D. C., prior to November 22, 1963, predicting that the assassination of President Kennedy would occur in the city of Dallas, Texas. been interested in "seers" and "scielics" and has always wondered whether they really could predict the fature. He said he has always followed for the fature to the predictions of Rostradaena, the state "Beer".

Inhoit said that be often ban discussed this topic with acquaintances in relation to predictions of the assassination of President Kennedy. We said that at no time had he ever made atkinates to anyone which would lead them to believe that to had any busyledge of the assassination prior to live operator.

Inhoff advised that at no time has he ever made any statements which could be construed as a threat, and the implied or actual, on the life of Chief Justice Warren • or any other man.

Mr. Imhoff said that he cannot recall any conversation in which he participated in a "Wextcan border town" in the Sparish language but that such a conversation is possible since he has often traveled to and from Mexico both before and after Movember 22, 1963.

Imhoff denied ever having any information concerning the assassination of the late President Kennedy other than that he had obtained from news media. He stated that he has never had knowledge of a "plot" to kill the President.

Imhoff stated that he is a citizen of the Maited States and of no other country.
