MISCELLANEOUS - INFORMATION CONCERNING

Enclosed for the Bureau and Houston are 10 and 3 copies respectively of a letterhead memorandum containing information furnished by DAVID MOREY WASS, JR.

The original information from WASS received by telephone on June 2, 1964, was taken by Night Clerk L. JOSEPH HERSLEY at the Dallas Office. WASS was interviewed on June 3, 1964, by SA's A. RAYMOND SWITZER and EUGENE F. PETRAKIS at Dallas, Texas.

The Houston Office advised by telephone on June 22, 1964, that WASS had furnished information to SA GRAHAM W. KITCHEL at Houston, Texas, on June 20 and 21, 1964.

Two copies of this letterhead memorandum have been furnished the U. S. Secret Service at Dallas, Texas, in view of WASS's statement that "LATTIMER" told him "The Syndicate" was not interested in President KENNEDY, but interested in BOBBY KENNEDY.

concerning WASS, it being noted that he stated he contacted a Lieutenant DUB BEALL of the Port Arthur Police Department.

Will identify the owner of the Golden Cask at Port Arthur, Texas, which, according to WASS, is owned by a PAUL COLLETTI (phonetic) and, if deemed advisable, interview him concerning WASS.

Will verify confinement of WASS at the Park Place Hospital, where he indicates he was attended by a Doctor BINSKY (phonetic).

HOUSTON at Houston, Texas, will verify employment of WASS as a Dental Technician by RALPH KESSLER, owner of Towers Dental Laboratory, Medical Towers Building.

HOUSTON should submit 25 copies of inserts and FD-302's of all investigation conducted by them, including interviews with WASS.

DALLAS will locate and interview JIM LATTIMER or LOUDERMILK, Room 5, 911 Haskell Street, bearing in mind the conversation WASS states he had with this individual, and the fact that WASS indicated that the individual told him if he betrayed the confidence he would be eliminated.
