In view of the President's Commission's anticipated early conclusion of the investigation of the assassination, Dallas and Houston are instructed to expedite the leads set out in referenced airtel.

The Bureau is disseminating to Secret Service Headquarters and to the Department the letterhead memorandum enclosed with referenced airtel. Houston, in addition to furnishing inserts to Dallas for inclusion in their report for the President's Commission, furnish the Bureau an appropriate letterhead memorandum revealing results of your investigation suitable for dissemination to Secret Service Headquarters and the Department. Insure meticulous accuracy to preclude revisions or corrections at the Bureau.

Dallas in referenced airtel did not give the Bureau benefit of any information contained in your files concerning Wass. Therefore, when you submit a subsequent letterhead memorandum concerning this matter, insure comments regarding Wass or any other individuals involved are included.

Bureau files contain no record for David Morey Wass, Jr., Jim Loudermilk, or Jim Lattimer. Bill Hayden, Jr., mentioned in your letterhead memorandum was not searched due to the common nature of this name, and for the lack of additional identifying data. Handle promptly.

Dallas airtel 6-22-64, furnished a letterhead memorandum in which information was obtained from David Morey Wass, Jr., who in brief, stated that he had made contact with "The Syndicate", and that this member had been talking to him regarding the assassination of President Kennedy. Allegedly the member of "The Syndicate" had stated the President's brother Robert Kennedy was supposed to have been killed. Wass mentioned several other individuals with whom he had contacts in connection with this matter, and he also admitted he received a medical discharge from the Air Force on September 15, 1943, which was diagnosed as psychoneurosis, anxiety type. According to Wass, Loudermilk's superior in "The Syndicate" is a Bill Hayden, Jr. There was no additional identifiable data on which a search could be based.

The letterhead memorandum is being furnished to the Department by O-6 and to Secret Service Headquarters by O-141.
