RECEIVED FROM THE PRESIDENT'S COMMISSION RELATING TO ROBERT
S. REYNOLDS WHO REQUESTED OPPORTUNITY TO APPEAR BEFORE THE
COMMISSION BASED ON ALLEGED INFORMATION HE HAD RE THE ASSASSINATION
OF PRESIDENT KENNEDY WHICH WAS ESTABLISHED IN THE EARLY MONTHS
OF ONE NINE FIVE SEVEN. THE COMMISSION DESIRED REYNOLDS BE
INTERVIEWED, AND BUREAU DESIRES ADDITIONAL INFORMATION WHICH
MAY INDICATE ANY INSTABILITY RE REYNOLDS. THIS MATTER IS TO
BE HANDLED EXPEDITIOUSLY AND RESULTS OF YOUR INQUIRIES ARE TO BE
FURNISHED TO THE BUREAU IN A LETTERHEAD MEMORANDUM. PHOENIX
