Rockville, Marylend. Mr. WILLIAMS said that according to his records, Mrs. SHAFFER has been employed at NIH as a payroll clerk since January, 1957. He said that he is aware she had prior government service; however, the time served and exact nature of her former employment is not reflected in records immediately available to him.

Mr. WIILIAKS stated that during the past two years, Mrs. SHAFFER has been on extended sick leave and leave without pay, after she used all of her accrued sick leave. He said that she has been on leave without pay since April, 1964, and will shortly be retired because of medical disability. He stated he has not had an opportunity to review medical records pertaining to the exact nature of Mrs. SHAFFER's medical disability and that he probably will not be permitted to review these suggestion records. However, he is aware that her disability appears to be a definite emotional problem. He commented that about two years ago he begen to notice that she appeared to be displeased with many things that occurred in her particular area of work and constantly complained to him and other of her superiors, hdicating that she believed she was being discriminated against because of her religious convictions. He said he is also aware that Mrs. SHAFFER has written many letters to various political figures throughout the United States charging that a religious order is attempting to undermine the Government of the United States in an effort to eventually take over: the control of the United States Government.

Mr. WILLIAMS said that he has seen Mrs. SHAFFER read a number of books, which, from casual perusal by him, indicate the authors of these books are castigating a particular religious sect.

Mr. WILLIAMS said that he does not know the identity of the physician who has been caring for Mrs. SHAFFER. He said she did not utilize the services of a government physician but insisted on seeing her private physician. Mr. WILLIAMS said he could add nothing to the above except the personal observation that Mrs. SHAFFER, who was at one time a valued and reliable employee in his section, now appears to be an extremely emotionally upset woran.





The individual stated that he worked at the Dental Arts Laboratory, Suite 206, Dorchester House, Dallas, Texas, and that he desired an Agent contact him as soon as possible at that location as he did not desire to discuss the matter further on the telephone. This individual stated that he was to be recontacted, either on Wednesday or Thursday evening, June 3 or 4, 1964, by the "Syndicate" member and, therefore, would like to be interviewed by an PBI Agent prior to his contact with this member of the "Syndicate". The individual stated that the best way to contact him would be to call him at work at any time and set up an appointment.

He advised that his chest and head were hurting so much that he called Lieutenant DUB BEALL, Port Arthur, Texas, Police Department, who advised that maybe he should go to the Park Place Hospital. The following investigation was conducted by SA JOHN G. HOUSTON at Port Arthur, Texas:

On June 25, 1964, Detective Lieutenant RICHARD SINGLETON, Identification Bureau, Fort Arthur Police Department, advised a review of the Port Arthur Police Department file, Number A 29,396, revealed that DAVID MOREY WASS, JR., who gave his address as the Carousel Motel, 330 Reveille Street, Houston, Texas, was arrested on March 20, 1964, by officers of the Port Arthur Police Department. WASS was charged with disturbing the peace at 5000 Gulfway Drive, Port Arthur, Texas. This charge was dismissed on March 21, 1964. A notation in the file reflects that WASS was drunk and causing a disturbance at the Colden Cask Club, cursing in front of women, and when asked to leave would not depart.

Detective SINGLETON advised that WASS was again arrested on March 24, 1964, on a charge of investigation, and the disposition shows he was released for the purpose of leaving toum on Harch 24, 1964. Detective SINGLETON furnished the following description of DAVID MOREY WASS, JR., as obtained from the Fort Arthur Police Department files:
