JANSON said, however, that unless he was specifically notified to retain this correspondence, he would probably continue to dispose of most of it. He said that unless something very unusual was received by him, he would not again contact this office, if it were not desired that he should retain the rather voluminous correspondence from Mrs. MARTIN.
