NOVEMBER TWENTY TWO, SIXTY THREE, DALLAS, TEXAS, MISCELLANEOUS -

INFORMATION CONCERNING.

REBUREAU RAD AUGUST TWENTY, LAST, AND URTEL AUGUST  
TWENTY ONE, LAST, CONCERNING POSSIBILITY OF ALL SAC COMMUNICATION  
TO EXPEDITE INVESTIGATION.

BASED ON INFORMATION AVAILABLE THERE DOES NOT APPEAR TO  
BE SUFFICIENT JUSTIFICATION TO CONTACT ALL CONTINENTAL OFFICES.

BEFORE FURTHER CONSIDERATION GIVEN, ADVISE NUMBER OF CONTINENTAL  
OFFICES NOW ENGAGED IN INVESTIGATION. IF MAJORITY OF OFFICES  
NOT INVOLVED, DALLAS SHOULD INITIATE COMMUNICATIONS TO THESE  
OFFICES TO EXPEDITE. MAKE EVERY EFFORT TO INCORPORATE AS MUCH  
UNRESOLVED INVESTIGATION IN REPORT IN CAPTIONED MATTER AT EARLY  
DATE WITH APPROPRIATE COMMENT AS INDICATED IN REBUREAU RAD.
