On 8/27/64, Mr. CHARLES BISANG of the above address advised that he was the brother-in-law of E. R. KEIBER. He stated that KEIBER was in the US Coast Guard during World War II and had left the Brooklyn area right after the war.

Mr. BISANG stated that his brother-in-law was never in a mental institution, and to the best of his knowledge did not have any friends or relatives at Kings Park State Hospital.

Mr. BISANG also advised that none of the names set out in the anonymous letters were familiar to him.

Mr. BISANG stated that KEIBER was presently living at 605 West Maple Street, San Diego, California.

In view of the fact that the Bureau has not set out leads to have the various individuals mentioned in the anonymous letters interviewed, no lead has been set out for the San Diego Office to interview KEIBER.
