Dear Mr. Rankin:

Reference is made to my letter dated September 11, 1964, which enclosed two copies of the report of Special Agent Robert P. Gemberling dated August 28, 1964, at Dallas, Texas, captioned "Assassination of President John Fitzgerald Kennedy, November 22, 1963, Dallas, Texas." This report contained the results of investigation conducted by this Bureau relative to allegations against persons other than Lee Harvey Oswald.

Enclosed for your assistance are two copies of another similar report prepared by Special Agent Gemberling dated September 18, 1964. Dissemination of this report has been made to Assistant Attorney General Herbert J. Miller, Jr. and U. S. Secret Service since it contains information of possible interest to them.

Your attention is invited to page four of the enclosed report relating to an alleged threat against Senator Everett H. Dirksen of Illinois. Upon receipt of this information Senator Dirksen's Office, Capitol Police and local Washington, D. C., police were notified. This information was also furnished to the U. S. Secret Service.

Received numerous complaints relating to individuals other than Lee Harvey Oswald. The complaints generally relate to remarks and threats allegedly made by individuals concerning their feelings about President Kennedy, other officials and the policies of the administration. The complaints are initiated by cranks, mental cases and patriotic citizens. This will be the eighth such report disseminated to the President's Commission. A copy will be disseminated to the Department and U. S. Secret Service separately. The enclosed report has been reviewed by Mr. Belmont, Malley and appropriate Bureau supervisor.
