For your information, communications similar to the one received by Attorney General Allan G. Shepard of Idaho bearing the name of Mr. Kraft have been referred to this Bureau from various sources.

By letter dated August 12, 1964, this Bureau furnished you with one copy of the report of Special Agent Robert P. Gemberling dated August 7, 1964, at Dallas, Texas, captioned "Assassination of President John Fitzgerald Kennedy, November 22, 1963, Dallas, Texas, Miscellaneous - Information Concerning." Pages twenty-eight to thirty-two of this report relate to our investigation of Mr. Kraft based on a letter he sent to Governor John B. Connally of Texas dated June 2, 1964. Mr. Kraft was interviewed by Agents of this Bureau on June 23, 1964. [REDACTED]
