The files of the New York Office of the Federal Burcau of Investigation reflect that a woman identifying herself as Margaret Hamill, also known as Margarct, Fillo, and Josephine Kennedy Powers, on May 13, 1964, telephonically informed the New York Office of the Federal Burcau of Investigation that she was having trouble obtaining a passport from the ρ_{n}, μ United States State Department. She indicated that she was married to John Patrik Hamill, an opera singer, who uses the professional name Giovanni Hillo. She and her husband were scheduled to go to Europe on the "SS France", May 14, 1954, and the State Department world not renew their paseport under the name Millo, but were forcing her to obtain a passport under their true name Hamili, and their attorney, David Carlyle of Washington, D.C. is requesting a \$500.00 fee to handle this matter.

Margaret Hamill indicated that she was at that time residing at the Plaza Hotel, New York, New York, in Rooms 463 and 470.

Margaret Hamill said that the facts concerning her use of the name Powers are known to the United States Secret Service. She said that she took the name Powers and that her husband took the name Carlton Powers, because prior to the assassination of President John F. Kennedy, she had been receiving a lot of "threatening telephone calls" regarding President Kennedy. She claimed that she was related to President Kennedy because her father was Joseph F. Kennedy, Jr., the late brother of President Kennedy.

She requested that a Federal Bureau of Investigation (FBI) agent accompany her to the United States Department of State to assist her in obtaining a passport. She was informed that passport matters are solely within the jurisdiction of the United States State Department.

There is no information reflecting that Nargaret Hamill at any time called the New York Office of the Federal Bureau of Investigation to report that President Kennedy was to be shot in Dallas, Texas. Also there is no information reflecting the Margaret Hamill reported a shot being fired at her while en route by train, from Washington, D.C. to New York.
