Check of Bureau indices located information
similar to that set out in referenced communications. For
your additional information Bureau file 161-2740 indicates
that in March, 1964, a discreet inquiry was conducted by
the Los Angeles Office concerning Hamill's allegation that
she is a member of the Kennedy family. The Bureau by
letter 2/29/64 advised the Attorney General of the information
developed at that time.

No other information identifiable with Hamill or
her aliases could be located in Bureau files. In addition
no information could be located indicating that she called
the Bureau reporting that the President was to be assis-
sinated or that she had been shot at while on a train from
Washington, D. C., to New York.

The letterhead memoranda submitted by referenced
communications have been disseminated to the Department and
the U. S. Secret Service. Any additional information
developed on Hamill and her associates should be submitted
in appropriate form for dissemination.

NOTE

Hamill, her husband and associates are known "con artists." Hamill apparently concocted a scheme whereby she now claims to be the illegitimate daughter of Joseph P. Kennedy, Jr., who was killed in World War II. She has had some success in this masquerade in having a photograph of herself taken with the late President's family in Ireland. Hamill allegedly has stated that she knew the President was to be killed and had advised appropriate authorities and further that she had been shot at by an unidentified individual while riding on a train. She claims this was reported to the FBI. We have no such information in our files and it appears she has made this statement to enhance her story of being connected with the Kennedys. As of this time no Federal violation exists.
