[REDACTED] CLAIMS ASSASSINATION OF PRESIDENT KENNEDY ARRANGED BY CRIMINAL GANG LED BY BILLY-DE'LOATCH, FBI NUMBER FOUR THREE NINE ZERO ONE THREE THREE, OF PHILADELPHIA AND CAMDEN, N.J., WHO WAS SHOT AND DIED WHILE BEING HELD UP IN CAMDEN, OCTOBER TWENTY ONE SIXTY FOUR.

IN LIGHT OF PRIOR INVESTIGATION AND WARREN COMMISSION REPORT, [REDACTED] INFORMATION QUESTIONABLE. WHEN PREVIOUSLY INTERVIEWED ON CRIMINAL MATTERS WHERE HE WAS SUBJECT OR SUSPECT, HE WAS EVASIVE, VAGUE AND NONSPECIFIC; EXHIBITED NERVOUSNESS AND EXCITABILITY; AND LIED, PROBABLY FOR SELF PROTECTION. POLYGRAPH INTERVIEW DESIRABLE IN EFFORT TO TEST PROBABLE VERACITY BEFORE ATTEMPTING EXTENSIVE INVESTIGATION BASED ON HIS CLAIMS.

SUGGEST NEWARK HOLD CAMDEN LEADS IN ABEYANCE, PENDING  
AUTHORIZATION AND CONDUCT OF POLYGRAPH EXAMINATION.
