Lric Frack Derglunt, who stated that his temporary address is in care of his finer, Mrs. Alice May Stillman, 114 West Cherry, McKezzie, Teansaces, Telsphone No. 352-2023, appeared at the Memphic Office of the Federal Eureau of Investigation on December 16, 1986 and furnished to a representative of the FBI information concerning varicus matters, all of which information he stated was based upon hearsay from fellow prisoners at various locations in the recent rast. Berglund stated that he was arrested by Agents of the F2I at Kerphis, Tennessee in late August of 1966, based on an indictment returned against him and Robert Dable Sparrow at Las Vegas, Nevada, charging then with Interstate Transportation of Sicler Property in ocamection with their hendling of Bose Bacurities. He stated he is presently free on bond agaiting trial. He stated that he was not furnishing information in the hope of receiving any consideration in the future from any Federal authorities but was furnishing information because he thought it wis his "duty as a citizen." Included in - the information furginhed by Bargland was the following:

In November, 1866, Berglund was confined in the County Jail in Cheyevae, Nyczing, Berglund at the time being under subpoena as a vitress in U. S. District Court, Cheyenne, although he was never called to testify. He had been taken by a United States Karshal from the Clark County Juli, Lus Vegas, Nevada, where he was confined avaiting trial to the County Jail at Cheyenne, Wyoning in order that he would be available in Cheyende to testify. While in the County Juil at Cheyeans he not and talked with a prisoner whose last mane was Fuller and whose first mane possibly was Robert. Fuller talked as though he was from a well to do family in the State of Kontana. On one occasion, Tuller started to tell Berglund about a "big spread" or zanch located in the State of Kontana and which was owned by some relative or in-law of fuller's. Berglund stated that as he recalled fuller told him that one of Fuller's sisters was married to the son of the pan who owns this "hig spread." Bargluni advised that Fuller furrished him no information of any king to indicate that anyone associated with the ranch had any consection whatever with his assuration of Fresident Kennedy or with any of the events leading to or following the assaustination. - Berglund also stated that fuller furbilished him no information to indicate that anyone at this reach possessed any type film not already available to all interested authorities. He stated that Fuller merely mentioned to him having seen some film, both movie and still pictographs, of the "Dallas Episode" and Eergland concluded that he, Bergluid, should furnish this information to some authorities since Fuller sugrested there are a "den of commists" at this reach where filzs of the Assassization were also shown.
