Dallas Office indices reflect numerous references regarding BUELL WESLEY/FRAZIER, 2439 W, 5th Street, Irving, Texas, who drove LEE HARVEY OSWALD to Dallas, Texas, from Irving on the morning of 11/22/63. FRAZIER indicated that OSWALD had a package with him wrapped in brown paper which OSWALD placed on the back seat of FRAZIER'S car. OSWALD described the contents of the package to FRAZIER as being curtain rods.

Dallas indices contain no information identifiable with MES. Which IE GARRETT; however, Dallas files reflect has contacted the Dallas Office as a complainant on numerous occasions. He has been described by interviewing Agents as possibly mentally unbalanced, as he has reported strange men following him and has been critical of the FBI. It is not furnished the Dallas Office any information of value in the past. Due to the above, no further investigation will be conducted concerning allegation, and no LHM will be submitted UACB.
