Assassination of President John Fitzgerald Kennedy, Dallas, Texas, November 22, 1963

// At 5:08 PM, on May 9, 1967, Carlos/Quiroga and Carlos/Bringuier, self-described anti-Castro Cuban exiles, appeared at the New Orleans Office of the Federal Bureau of Investigation (FBI) and voluntarily furnished the following information:

Quiroga stated that on May 9, 1967, he had been contacted by Salvadore/Panzeca, attorney for Clay Shaw, who advised him that Orleans Parish District Attorney, James Garrison, plans to indict Quiroga on perjury charges when he appears before an Orleans Farish Grand Jury on May 10, 1967. Panzeca stated that Garrison will attempt to show that Quiroga and Bringuier were at an anti-Castro training camp on the shores of Lake Ponchartrain with Lee Harvey Oswald. This camp was reportedly run by an individual known as Richard Davis and persons there were being trained to burn sugar cane in Cuba.

> Clay Shaw is a subject in the inquiry by District Attorney (DA) Garrison into the death of President John Fitzgerald Kennedy.

Quiroga advised that Davis was in New Orleans, Louisiana, on March 18 or 19, 1967, during which time he stayed at the Royal Orleans Hotel under an assumed name. Davis' purpose in being in New Orleans was to show a "Time-Life" correspondent, who was accompanying him, the location of his former training camp./ Davis was also to take this correspondent to see Sergio/Arcacha 'Smith, former Cuban exile leader in New Orleans. For this, Davis was to be paid \$300.00.

During a conversation with Davis, he advised Quiroga that he would do anything for money. Subsequent to this, Quiroga learned that Davis had attempted to sell a story to the National Broadcasting Company which put a Clay Bertran at this camp.

> The name Clay Bertran is an alias which DA Garrison claims was utilized by Clay Shaw!

Both Quiroga and Bringuier emphasized the fact that they had never been at Davis' training camp. However, they admitted they were aware of its existence.

Bringuier stated that on April 30, 1967, he received a telephone call from Alberto Fowler, Director of International Relations for the City of New Orleans and Investigator for DA Garrison. During this conversation, Fowler stated that Garrison plans to prove that it was Gordon Novel who pulled the trigger in Dallas and not Oswald. Bringuier advised that he tape recorded this conversation with Fowler.

> Gordon Novel is a key figure in the investitaion of DA Garrison and is currently fighting extradition from the State of Ohio.
