ASSASSINATION OF PRESIDENT JOHN FITZGERALD KENNEDY, DALLAS,
TEXAS, NOVEMBER TWENTYTWO SIXTYTHREE, INFO CONCERNING.

ON FIVE NINE INSTANT, CARLOS BRINGUIER AND CARLOS QUIROGA APPEARED AT THE NEW ORLEANS OFFICE AND REQUESTED THAT AN AGENT SPEAK WITH THEM. QUIROGA ADVISED THAT HE HAD BEEN INFORMED THIS DATE BY SALVATORE PANZECA, ATTORNEY FOR CLAY SHAW, THAT DA GARRISON PLANS TO INDICT QUIROGA ON PERJURY WHEN APPEARS BEFORE ORLEANS PARISH GRAND JURY ON FIVE TEN NEXT. GARRISON WILL REPORTEDLY ATTEMPT TO SHOW THAT QUIROGA AND CARLOS BRINGUIER WERE AT AN ANTI-CASTRO TRAINING CAMP WITH LEE HARVEY OSWALD.

BRINGUIER ADVISED THAT ALBERTO FOWLER, INVESTIGATOR FOR DA GARRISON, TELEPHONICALLY CONTACTED HIM ON FOUR THIRTY LAST AND AT THIS TIME STATED THAT GARRISON PLANS TO SHOW THAT GORDON NOVEL WAS THE INDIVIDUAL WHO SHOT PRESIDENT KENNEDY IN DALLAS.

BRINGUIER INDICATED THAT HE TAPE RECORDED THIS CONVERSATION.
