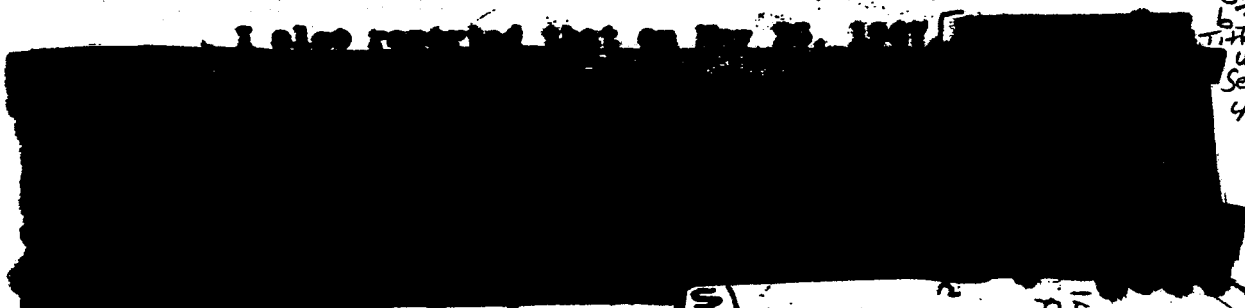

By letter dated 5/22/67 New Orleans District Attorney Garrison informed SAC Rightmyer of our New Orleans Office that he had discovered a draft of a letter prepared by Gordon Nevel wherein Nevel claimed to have knowledge of the Double-Check Corporation. Garrison also indicated that Double-Check Corporation had been reported in a book entitled "The Invisible Government," as being connected with CIA. We contacted CIA and were furnished the information which is set forth herein under the date of 5/25/67. On 6/2/67 [redacted] CIA, [S] informed Liaison Representative [redacted]
