WDSU RADIO NEWSREPORT FIVE P.M. THIS DATE REPORTED THAT
WILLIAM H. GURVICH, FORMER CHIEF AIDE TO DISTRICT ATTORNEY JIM
GARRISON IN THE KENNEDY ASSASSINATION PROBE, SAID GARRISON ONCE

PLANNED A RAID ON THE NEW ORLEANS FBI HEADQUARTERS. GURVICH SAID
RAID WAS PLANNED FOR MIDNIGHT, WHEN ONLY ONE PERSON WOULD BE
ON DUTY AND "RED PEPPER GUNS" WOULD BE USED TO IMMOBILIZE
ANY FBI AGENTS WHO MIGHT SURPRISE THEM DURING THE RAID.

ACCORDING TO GURVICH, PURPOSE OF RAID WAS TO CONFISCATE SOME
AUDIO TAPES GARRISON THOUGHT THE FBI HAD OF TELEPHONE CONVER-
SATIONS OF GARRISON AND MEMBERS OF HIS STAFF.

THE NEWS REPORT STATED GURVICH CLAIMED GARRISON PLANNED
TO ARREST WALTER SHERIDAN OF NBC. GURVICH SAID GARRISON
HAD STATED HE WANTED SHERIDAN ARRESTED, HANDCUFFED, BEATEN
AND BROUGHT INTO HEADQUARTERS.

WDSU NEWS REPORT AT SIX PM REPORTED GURVICH SAID GARRISON
PLANNED OTHER ARRESTS IN NEW ORLEANS ON CHARGES OF ACCESSORIES
AFTER THE FACT, LISTING THOSE TO BE ARRESTED AS ONE OF THE
MOST PROMINENT DOCTORS OF INTERNATIONAL REPUTATION, TWO CUBAN
REFUGEE LEADERS, AN FBI AGENT ASSIGNED TO THE LOCAL OFFICE,
THE OWNER OF ONE OF THE LARGEST LOCAL HOTELS, AND A LEADING
NEW ORLEANS COFFEE IMPORTER. GURVICH DECLINED TO FURNISH
THE NAMES OF THOSE INDIVIDUALS GARRISON PLANNED TO ARREST.
