[REDACTED] read and executed a waiver of rights form and then furnished the following information:

Upon examining a photostat of a letter which read "Cyanide gas is a terrible way to die. Perhaps you will all be given a Choice," he advised he recalls his hand having held the pen which wrote the letter but that actually [REDACTED] wrote the letter. Upon examining a photostat of a letter which begins "It now appears I have to explain something" and ends with "I'm not wrong so don't disregard this, [REDACTED]" advised [REDACTED] also used his body to write this letter. He witnessed [REDACTED] using his body to write the letters but was unable to stop him.

[REDACTED] said he wanted to explain what he meant, as follows:

[REDACTED] is an alias he commonly uses. [REDACTED] and [REDACTED] inhabit the same body, but are two entirely different persons. He described [REDACTED] as a mischievous person who is always getting into trouble, and [REDACTED] then has to try to get [REDACTED] out of trouble.

He received a job through [REDACTED] of the Consultants and Designers Company at the Aerospace Center of Motorola, Incorporated, at Phoenix, Arizona. After working a few hours he was compelled by an outside force to leave Phoenix, which he did. He noted he cannot always control his movements if [REDACTED] is in control of his body.

[REDACTED] has been most kind to him and neither he or [REDACTED] have any malice toward [REDACTED] and have never had any intentions of harming him or anyone else. Neither he or [REDACTED] would ever use any physical violence toward any animal or person.

He does not know why [REDACTED] wrote the letters, except that he is always doing something to get [REDACTED] into trouble. He described himself as Dr. Jekyll and [REDACTED] as Mr. HYDE.

At this point he stated he did not know who was then talking to SA MC CARTY, if it was [REDACTED] or [REDACTED]

He stated he started changing a couple of years ago, has undergone tremendous emotional stresses, but within the past couple of months has begun to realize how things should be, and is now able to understand things better. He has studied dream analysis deeply and is presently the best informed person in the world on dream analysis.

He noted he was in the Brockton, Massachusetts, Veterans Administration Hospital for ten days for observation in January, 1967, and was in the Veterans Administration Hospital at Sheridan, Wyoming, in October, 1966, for about ten days for observation. This latter confinement was because he contacted Park Rangers at Yellowstone National Park with the offer to use his extrasensory perception in locating a lost boy, but said the Rangers "had me locked up instead."

[REDACTED] advised [REDACTED] stole a blue 1964 Ford convertible, with California license, the last three numbers being 753, from an apartment house in Mountain View, California on May 17, 1967. He said [REDACTED] left this car in the Sun Valley Lodge parking lot at Sun Valley, Idaho, the same day I took the doctor's car, the Porsche, from Sun Valley."

[REDACTED] took the Porsche to Columbia, Missouri, where he abandoned it on Clinton Street.

[REDACTED] also took a 1966 Ford Thunderbird convertible from the Hertz Rent-A-Car at the Los Angeles, California, airport about December 15, 1966, and abandoned it in the police parking lot at Hollywood, California. He said this was a car stolen by [REDACTED] and was not a rented car.
