He stated he started changing a couple of years ago, has undergone tremendous emotional stresses, but within the past couple of months has begun to realize how things should be, and is now able to understand things better. He has studies dream analysis deeply and is presently the best informed person in the world on dream analysis.

He noted he was in the Brockton, Massachusetts, Veterans Administration Hospital for ten days for observation in January, 1967, and was in the Veterans Administration Hospital at Sheridan, Wyoming, in October, 1966, for about ten days for observation. This latter confinement was because he contacted Park Rangers at Yellowstone National Park with the offer to use his extrasensory perception in locating a lost boy, but said the Rangers "had me locked up instead."
