SA REGIS L. KENNEDY WAS SERVED WITH A SUBPOENA AT HIS RESIDENCE AT APPROXIMATELY EIGHT A.M. THIS DATE TO APPEAR AUGUST NINE, SIXTYSEVEN, TO TESTIFY IN THE CASE OF THE STATE OF LOUISIANA VS. DEAN A. ANDREWS, JR., DEFENDANT. THE DETAILS REFLECTED ON THE SUBPOENA ARE IDENTICAL TO THOSE ON AS REED W. JENSEN'S SUBPOENA, WHICH IS SET FORTH IN DETAIL IN REFERENCED TELETYPE SIX TWENTYSIX. P.M., AUGUST ONE LAST.
