LIEBELER WHEN QUESTIONED UNDER OATH IN SIXTYFOUR THAT A
MAN NAMED CLAY BERTRAND HAD CALLED HIM AFTER THE ASSASSINATION
OF PRESIDENT KENNEDY AND ASKED HIM TO DEFEND ACCUSED
ASSASSIN LEE HARVEY OSWALD.

THE ARTICLE STATES THAT LIEBELER WAS ASKED TO COME TO
NEW ORLEANS VOLUNTARILY TO TESTIFY AUG. NINE AND TEN NEXT
BUT THAT HE REFUSED AND ASSISTANT DA ALCOCK TODAY FILED
A REQUEST FOR ATTENDENCE BY LIEBELER WITH CRIMINAL DISTRICT
JUDGE FRANK J. SHEA WHO WILL PRESIDE. JUDGE SHEA ACCORDING
TO THE ARTICLE SIGNED AN ORDER FOR LIEBELER'S RETURN AND
AN ORDER FOR FUNDS TO COVER HIS TRAVEL EXPENSES. THE
ORDER IS BEING FORWARDED TO THE COURTS IN WINDHAM COUNTY,
VERMONT, INASMUCH AS LIEBELER IS NOW LIVING IN NEWFANE,
VERMONT WHICH IS IN WINDHAM COUNTY.
