HAD BEEN INTERVIEWED BY THE FBI BUT NOT IN CONNECTION VIOH THE ASSASSATION FLOT.

STATED THAT HE RECALLED HAVING BEEN CONTACTFINE BY THE FRI ABOUT THE TIME OF THE ASSASSINATION BUT NOT IN CONNECTION WITH THE ASSASSINATION.

HEASSUMES THAT THE FEI HAS RECEIVED INSTRUCTIONS TO THOLOUGHLY CHECK HIM OUT IN VIEW OF THE RECENT ALLEGATIONS of district attorney James Carrison against him. He said that he VANTED TO VOLUNTEER THAT HE WILL ASSIST THE FBI IN ANY WAY IF THERE IS ANY DESIRE TO INTERVIEW HIM SINCE HE HAS ABSOLUTELY NOTHING TO HIDE. HE HAS PUBLICLY VOLUNTEERED TO TAKE A POLYGRAPH EXAMINATION FROM ANY RESPONSIBLE PUBLIC ABFNCY INCLUDING THE FEI. HE SEIF THAT CIVIL POLYCRAPH FXAMINER CHITS GUGAS HAD CALLED AND VOLUNTEERFE HIS SERVICES. HE AND HIS ASSOCIATES HAD CHECKED AND FOUND THAT GUGAS HAD A GOOD REPUTATION, SO HE HAD SUBMITTED TO REFERTED POLYGRAPH FXAMINATIONS OVER PERIOD OF SEVERAL DAYS. HE SAID THAT AT A PLESS CONFERENCE YESTERDAY, GUGAS SAID IN EVENT THAT IF IS NOT INNOCENT IN THE KENNETY ASSASSINATION PLOT, THEN GUGAS WOULD "TUFN IN LICENSE". AS FAR AS HE KNOVS, NEW OFLEANS DISTRICT ATTORNEY JAMES GARRISON HAS NOT TAKEN ANY STEPS WHATEVER TOWARD EXTRADITING HIM FROM CALIFORNIA AND THAT GARRISON'S APPARENTLY MERFLY "TRYING ME IN THE PAPER".
