RE: ASSASSINATION OF PRESIDENT JOHN FITZGERALD KENNEDY NOVEMBER 22, 1963, DALLAS, TEXAS

Pursuant to the request of Nr. Edwin L. Weisl, Jr., Assistant Attorney General, Civil Division, U. S. Department of Justice, Washington, D.C., dated December 1, 1967, the following is submitted to assist the government in its defense of the suit captioned John J. King vs. United States of America (United States District Court, District of Colorado, Civil Action No. 67-C-518):

One 6.5 mm. Mannlicher-Carcano rifle, with telescopic sight, Serial No. C2766, including sling and cartridge clip. (Warren Commission Exhibit No. 139) (FBI Exhibit C14)

This exhibit was originally taken into custody November 22, 1963, by Lieutenant John Carl Day and Captain J. W. Fritz, Homicide and Robbery Bureau, Police Department, Dallas, Texas, after it was found on the sixth floor of the Texas School Book Depository in Dallas. Custody was initially obtained by Federal authorities November 22, 1963.
