ASSASSINATION OF PRESIDENT  
JOHN FITZGERALD KENNEDY, NOVEMBER 22, 1963  
DALLAS, TEXAS

On December 6, 1967, [REDACTED],  
United States Navy, National Security Agency, Fort George  
G. Meade, Maryland, was interviewed at his request on that  
date by Special Agents Bruce H. Norwell and John A. Olmstead  
of the Naval Investigative Service and furnished the following  
information:

He advised on December 5, 1967, he received an  
anonymous letter at his residence, [REDACTED], Fort  
Meade, Maryland, which contained information regarding the  
assassination of President John F. Kennedy. [REDACTED] advised he  
believed letter was misdirected to his attention inasmuch as  
it had been addressed to a [REDACTED] Bethesda Naval  
Hospital, Bethesda, Maryland, and had been forwarded to his  
address.

[REDACTED] advised he was a patient at Bethesda Naval Hos-  
pital from mid July and in August, 1967, but he had met no one  
who would have written such a letter. He added he was aware  
that there had been a [REDACTED] United States,  
Navy who was attached to the Medical School at Bethesda, Mary-  
land.

[REDACTED] available the letter and envelope he received. The letter is a four page handwritten letter beginning "Dear [REDACTED]" and signed "One who feels your suffering."

Copies of the aforementioned envelope and letter were furnished the Washington Field Office, Federal Bureau of Investigation and United States Secret Service by [REDACTED] United States Navy Reserve by letter dated December 28, 1967.

[REDACTED] in his letter of transmittal stated the letter received by [REDACTED] was probably intended for [REDACTED] Medical Corps, United States Navy who took part in the autopsy of President Kennedy and who has since retired and resides at 1336 Lochmoor, Grosse Point Woods, Michigan, 48236.

Copies of the aforementioned letter and envelope are attached hereto.

This document contains neither recommendations nor conclusions of the FBI. It is the property of the FBI and is loaned to your agency; it and its contents are not to be distributed outside your agency.


