THE NEW ORLEANS STATES-ITEM, RED COMET EDITION, FEB.  
TWENTYTWO, SIXTYEIGHT, REPORTED THAT GORDON NOVEL, LONG  
SOUGHT WITNESS IN THE KENNEDY ASSASSINATION PROBE, STATED  
HE WILL RETURN TO NEW ORLEANS. ACCORDING TO THE ARTICLE  
NOVEL SAID YESTERDAY IN COLUMBUS, OHIO HE IS "TIRED OF  
FIGHTING" AND WILL APPEAR BEFORE ORLEANS PARISH GRAND JURY  
ON MARCH SEVEN AND EIGHT.

THE ARTICLE STATED THAT NOVEL SAID HE KNOWS NOTHING  
THAT HE CAN TELL THE GRAND JURY IN CONNECTION WITH GARRISON'S  
ALLEGATION THAT THE SLAYING OF PRESIDENT JOHN F. KENNEDY  
WAS PLOTTED IN NEW ORLEANS.
