NEW ORLEANS STATES-ITEM FINAL EDITION MAY THIRTEEN,
INSTANT, REPORTED THAT THE ORLEANS PARISH DISTRICT ATTORNEY'S
OFFICE SUBPOENAED DR. STANLEY L. DRENNAN OF LOS ANGELES AND
CLINTON WHEAT OF BURNEY, CALIFORNIA, TO TESTIFY BEFORE THE
ORLEANS PARISH GRAND JURY IN CONNECTION WITH THE KENNEDY
ASSASSINATION PROB ON MAY TWENTYNINE AND THIRTY, SIXTYEIGHT.

ACCORDING TO THE ARTICLE IN REQUESTING THE SUBPOENAS
THE DISTRICT ATTORNEY'S OFFICE ALLEGED THAT DR. DRENNAN WAS
PRESENT IN SIXTYTHREE AT A DISCUSSION CONCERNING THE ASSASSINATION
OF PRESIDENT KENNEDY. THE DISTRICT ATTORNEY'S OFFICE
FURTHER ALLEGED THAT WHEAT IN SIXTYTHREE PARTICIPATED IN
DISCUSSIONS AT HIS HOME REGARDING THE ASSASSINATION.
