Mr. Hoover:

Ever since the assination of our late President John F Kennedy, the police officer, the death of Lee Harvey Oswald and Jack Ruby. That would mean Mr. Hoover that the deed that was done by Jack Ruby to Lee Harvey Oswald was not murder but an execution prescribed by God and his Law system. I will express those laws in this manner. Lee Harvey Oswald was on trial while he sat in the jail cell in Dallas.

For the life of John F. Kennedy and for the life of the police officer God applied his laws in this manner.

Mister Hoover I would like to come to Washington and discuss the matter with you on all the subjects mentioned. Would you please write me back. If you except the offer to discuss the matters mentioned would you also send for Mrs Kennedy to be in your office.
