WATSON advised that SIMS mentioned FRENCH reportedly purchased a gembling stamp from the Federal Government for 1968, but SIMS did not furnish any other information concerning the address or other information in connection with the gambling stamp.

New Orleans indices reflect several references to a JAMLS LOUIS FRENCH; JAMES HAROLD FRENCH, aka Jimmy French; however, it is not known if these references, which involve interviews concerning ITSMV, ITSP, and FAG violations, pertain to JIMMY FRENCH wanted by the District Attorney's Office, New Orleans. References concerning JAMES HAROLD FRENCH indicate that he was age 40 in 1965, W/M, and resided in Texas City, Tex., in 1965. JAMES HAROLD FRENCH, aka Jimmy French, was interviewed on 12/12/66 in connection with an ITSP matter; and at that time, FRENCH resided at Rt. 2, Box 75, Winnfield, La. His wife is listed as MARY ALICE FRENCH.

As stated above, it is not known if these New Orleans references, concerning JAMES HAROLD FRENCH, are identical to the JIMMY FRENCH in question.
