ASSASSINATION OF PRESIDENT JOHN
FITZGERALD KENNEDY, NOVEMBER 22,

Reference is made to memorandum captioned as above
and dated April 4, 1968, at Tampa, Florida, in which informa-
tion concerning Fred G. Voelker was set forth.

There is set out below the contents of a letter
received by the Tampa Office of the Federal Bureau of Investi-
gation from Fred Voelker, 215 West Fairview, Tulsa, Oklahoma.

Much of this year one of your men
called me in regards to a letter I
wrote to Sen. Kennedy. I moved April 9-68
I had the St. Peterburg Transfer and Storage
Co. specify that my T.V. and send some to
me. They paid \$150. and sent to me via
Railway Express. several. I wrote to them
three times they would not answer.

The best friend of all this is that
a Jew Dr. at Danville Ill. Vet Hospital he
keep me locked 45 months, stood the
Government (Japan) coming to bomb
Rosa Parks, the Jew Dr. after 45 months
called me a "N. Y. Dick in a Card"
Sung a bitch, sent me nothing
a will with you, gave me a pass to go
