UNSUB, DRIVER, NEVADA LICENSE THREE ZERO TWO SIX FIVE AND FLORIDA LICENSE TWO W W THREE ZERO EIGHT THREE, THREAT AGAINST PRESIDENT OF THE UNITED STATES.

[REDACTED] PM OF JUNE TWELVE INSTANT, APPEARED AT LAS VEGAS OFFICE AND FURNISHED FOLLOWING CONFIDENTIAL INFO:

STATES TWO OR THREE DAYS AGO A MAN, NAME UNKNOWN, WHO ALSO RESIDES IN ROOMING HOUSE AT [REDACTED] AS VEGAS, NEVADA, INFORMED THAT HE KNEW JOHN F. KENNEDY WAS GOING TO BE ASSASSINATED TWO YEARS PRIOR TO PRESIDENT KENNEDY'S ACTUAL

ASSASSINATION. STATES THIS MAN CLAIMED HE TRIED TO BRING THIS TO ATTENTION OF FBI THREE MONTHS PRIOR TO ACTUAL ASSASSINATION.

STATES THIS MAN CLAIMS HE HAS HAD PROBLEM WITH SECRET SERVICE AND THEY HURT HIM ON ONE OCCASION.

JUN 14 1968

STATES THIS MAN DRIVES A VESPA MOTOR SCOOTER, NEVADA LICENSE THREE ZERO TWO SIX FIVE, AND A CADILLAC WITH FLORIDA LICENSE TWO W W THREE ZERO EIGHT THREE, BOTH OF WHICH ARE PARKED IN VICINITY OF [REDACTED] LAS VEGAS.
