Your communication of August 4th to the Congressional Liaison Office of the Department of Justice enclosing a letter from Miss Faye Figelsky of Southfield, Michigan, concerning the reopening of the investigation of the assassination of President John F. Kennedy has been referred to my office.

As I am sure you and your constituent are aware, this Bureau conducted a prompt, intensive and objective investigation of the assassination of President Kennedy at the request of President Lyndon B. Johnson. Results of our investigation were fully and accurately reported to the President's Commission on the Assassination of President Kennedy. All available evidence pointed to one conclusion-- that Lee Harvey Oswald acted alone in this crime.

In the interest of thoroughness and justice, the FBI does conduct follow-up inquiries into new allegations regarding the assassination of President Kennedy when appropriate; however, there have been no developments which would raise doubts as to the conclusions of the Warren Commission or warrant the reopening of a full investigation.

As you have requested, your enclosure is returned herewith.
